

# CHANGE OF SEASONS JURIED EXHIBITION

## 2012 Adult Division—Complete Entry Guidelines

### JUROR: STEVEN PETERS, SCULPTOR AND GVSU ART INSTRUCTOR

Steven Peters' sculptural works have been in numerous exhibitions throughout the Midwest, including ArtPrize 2010 and Grand Haven's ArtWalk in 2011. Although known for his large "ceremonial" pieces constructed out of recycled materials such as steel, wood, and brass, he has also explored other forms in ceramic, blown glass, fine metals, and print-making. Regional collections and commissions include the State of Michigan, Lowell High School, Norton Shores and Spring Lake Library. He currently teaches art at Grand Valley State University.

### ELIGIBILITY

▪ Open to Michigan artists 18 years and older. ▪ Original works completed within the past two years and not previously exhibited in a juried White River Gallery exhibition are eligible. Original implies work not taken from another artist's work. ▪ Adult entries should be completed without the assistance of an instructor. ▪ Any medium is accepted. ▪ There is no theme or required subject matter. ▪ Due to wall space restrictions, a limited number of large pieces (50"x50") can be accepted.

### ENTRY PROCEDURE AND FEES

▪ There is a non-refundable entry fee (total) of \$10 for White River Gallery members and \$20 for non-members. ▪ Each artist may submit up to two works. ▪ Adult entries must be delivered to the White River Gallery, 8701 Ferry Street, Montague MI 49437. ▪ Artwork must be dropped off during the designated times unless other specific arrangements have been made. ▪ All forms must be completed in their entirety to ensure correct identification and pricing. ▪ A self-addressed, stamped envelope must accompany your completed forms in order to receive jury notification. ▪ Award winners will be notified by phone.

### FRAMING AND LABELING

▪ Adult work must be properly framed with no exposed glass edges, wired, and ready to hang. ▪ No saw-tooth hangers accepted. ▪ Affix entry labels firmly to the back of the entries, in the upper right corner. ▪ For three-dimensional work, entry labels must be tied, taped or pinned securely to each piece. ▪ Unsuitably prepared work may be declined.

### CONDITIONS AND LIABILITY

▪ Accepted adult division artwork must remain on display at White River Gallery for the duration of the exhibit. ▪ All works in the adult division must be for sale. ▪ No "Price on Request" (POR) accepted. ▪ A 36% commission will be charged on all adult division artworks sold during the exhibit. ▪ White River Gallery takes every precaution to ensure the protection of artwork. However, we are not responsible for any loss or damage. ▪ Insurance is the responsibility of the artist.
